ORDINANCE NO. 08-3 (Amended)

Amendment # 256 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Norman Tomas Parcel In The Town Of Buena Vista.

The Richland County Board of Supervisors does hereby ordain as follows:

- 1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:
 - (a) Adequate public facilities to serve the development are present or will be provided.
 - (b) Provision of these facilities will not be an unreasonable burden to local government.
 - (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
 - (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
 - (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
 - (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
 - (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.
- 2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described real estate in the Town of Buena Vista is hereby rezoned from the General Agricultural and Forestry District to the Agricultural and Residential District:

All that part of the Southwest Quarter (SW½) of the Southwest Quarter (SW½) of Section 8, T. 9 N., R. 2 E., Township of Buena Vista, Richland County, Wisconsin bounded and described as follows:

Commencing at the Southwest Corner of said Section 8; Thence N 00°-37'-32" W, 364.98 feet along the West Line of the Southwest Quarter (SW½) of said Section 8, line being within the Right-of-Way Limit of Old Sextonville Road; Thence leaving said Right-of-Way S 85°-44'-29" E, 591.63 feet to an iron pipe; Thence S 02°-02'-19" E, 158.26 feet to an iron pipe; Thence S 58°-16'-34" E, 146.69 feet to an iron pipe; Thence N89°-52'-27"E, 146.70 feet to an iron pipe; Thence S 03°-26'-59"E, 78.25 feet to an iron pipe situated on an existing fence line; Thence S 89°-28'-32"W, 867.85 feet along said existing fence line to the point of commencement.

BE IT FURTHER ORDAINED that this Ordinance shall be effective on February 19, 2008.

Ordinance No. 08-4 (Amended)

An Ordinance Designating An All-Terrain Route And Establishing Regulations.

The Richland County Board of Supervisors does hereby ordain as follows:

Richland County Clerk

- 1. "All-terrain vehicle" means an engine-driven device which has a net weight of 900 pounds or less, which has a width of 48 inches or less, which is equipped with a seat designed to be straddled by the operator and which is designed to travel on 3 or more low-pressure tires. A low-pressure tire is a tire which has a minimum width of 6 inches, which is designed to be mounted on a rim with a maximum diameter of 12 inches and which is designed to be inflated with an operating pressure not to exceed 6 pounds per square inch as recommended by the manufacturer.
- 2. "All-terrain vehicle route" means a highway designated for all-terrain vehicle operators by the government agency having jurisdiction as authorized under Wisconsin Statutes, section 23.33.
- 3. "Roadway" means that portion of a highway between the regularly established curb lines or that portion which is improved, designed or ordinarily used for vehicular travel, excluding the berm or shoulder. In a divided highway the term "roadway" refers to each roadway separately but not to all such roadways collectively.
- 4. Counties are authorized by Wisconsin Statutes, section 23.33 (8) (b) to designate county trunk highways within the county as all-terrain vehicle routes.

- 5. Counties are authorized by Wisconsin Statutes, section 23.33 (11) (a) to enact ordinances regulating all-terrain vehicles on all-terrain vehicle routes designated by that County.
- 6. Richland County Trunk Highway JJ from U.S. Highway #14 East to State Trunk Highway #130 in the Town of Buena Vista, a distance of approximately 3.8 miles, is hereby designated as an all-terrain vehicle route.
- 7. In addition to all requirements, rules and regulations regarding the operation of all-terrain vehicles set forth in the Wisconsin Statutes and in the Wisconsin Administrative Code, the following rules shall apply to the operation of all-terrain vehicles on the all-terrain vehicle route designated in this Ordinance:
 - (a) All-terrain vehicles shall be taken to and from the all-terrain vehicle route on a trailer towed by a licensed motor vehicle.
 - (b) Operation is authorized in single file only and only for the extreme right side of the roadway except that left turns may be made from any part of the roadway which is safe given prevailing conditions.
 - (c) Speed shall not exceed 30 miles per hour except that speed shall not exceed 10 miles per hour, and the operator shall yield the right-of-way, when traveling within 100 feet of a person who is not on an all-terrain vehicle, a snowmobile or a motorcycle except as provided in Wisconsin Statutes, Chapter 346, where applicable. Speed shall not exceed 10 miles per hour within 150 feet of a residence.
 - (d) Operation shall only be between one half hour after sunrise to one half hour before sunset as set in The Wisconsin State Journal for that day.
 - (e) The headlight and taillight of the all-terrain vehicle shall be illuminated at all times during operation.
 - (f) Operators under the age of 16 must be accompanied by a person who is at least 18 years of age.
 - (g) Operators under the age of 18 must wear a helmet and must have a Wisconsin Department of Natural Resources safety certificate on their person while operating an all-terrain vehicle.
 - (h) All-terrain vehicles shall have a spark arrester in the muffler.
- 8. The County Highway Commissioner, with the assistance of and with full funding from the Wisconsin River Runners All-Terrain Vehicle Club, shall ensure that the all-terrain vehicle route designated by this Ordinance shall be properly signed in accordance with section NR 64.12, Wisconsin Administrative Code.
- 9. Violations of this Ordinance shall be punished by a forfeiture, not including court costs and assessments as provided by law, which shall be added to the following base forfeiture:

First offense \$ 50.00 Second offense \$ 100.00 Third offense \$ 150.00

Fourth offense and

- 10. This Ordinance shall be enforced by the Sheriff of Richland County, who is hereby authorized to issue citations for violations of this Ordinance, and by the Wisconsin Department of Natural Resources. Violations shall be prosecuted by the District Attorney of Richland County.
- 11. The Clerk shall send a copy of this Ordinance to the Wisconsin Department of Natural Resources and the Clerk shall also provide a copy of this Ordinance to the Sheriff.

The order of consideration of agenda items shall be at the discretion of the Chairman. The Board may only consider resolutions or ordinances which each member has been sent a copy of in accordance with Rule 1: exceptions to this rule may be made only in the case of an emergency as determined by a majority of those present."

2. As to the 3rd paragraph of Rule #5, the following underlined words are added:

"In the event of a prolonged, unexcused absence of a member of a committee or board, the chair of that committee or board shall notify the County Board Chair of the absence. Except as to the Highway Committee and the Board of Trustees of Pine Valley Healthcare & Rehabilitation Center, the Chairman shall have authority to make temporary committee appointments upon the prolonged, unexcused absence of any committee or board member, after the approval of such appointments by a majority of the County Board. Such temporary appointments shall cease upon the return of the absent member."

3. The last paragraph of Rule #5 is deleted:

"Resolutions arising out of committee meetings held between the date on which Resolution have been send out and the County Board meeting shall not be considered until the subsequent county Board meeting, unless the County Board determined by a majority vote than an extreme emergency exists."

- 4. As to Rule #19, paragraphs (a) 3 and 4 are repealed and paragraph 5 is renumbered to be paragraph 3:
 - (a) Policy as to reimbursement for overnight lodging:....
