September 22, 2009

Approximately \$438,700 of the funds will be used for the County to purchase the floodway property of WRCO, demolish and remove the building and convert the area to green space. Funds will also be used for purchasing and remodeling a new property for WRCO and for moving expenses. The remaining \$468,000 will be used to elevate four homes to above flood stage. The County will administer the grant and pay the contractors upon completion of each project.
