Dr. Patrick Glenn Hagen, UW-Richland Executive Officer and Dean, introduced Koshy Samuel, from ESG by Honeywell. The UW-Richland selected Honeywell to perform an in-depth energy audit of the campus to identify areas of savings with respect to controls, HVAC, lighting, electrical, mechanical, plumbing and building envelope. The Wisconsin Department of State Facilities has an allocated budget of \$100 million for energy efficiency programs in state facilities, including the UW system. Hard cost energy savings derived by the energy efficiency measures must pay for themselves within an aggregate 16.07 year payback period. Based on the analysis by Honeywell the UW-Richland will have over \$607,500 in energy efficient projects performed on the campus. These projects will be performed at no cost to the County or the UW-Richland. Honeywell guarantees the savings. The decision was made to not include the replacement of the boilers in the projects because including their replacement would extend the payback period beyond the 16.07 year payback period requirement to qualify for state funding.

Ordinance No. 12-3 Amendment # 330 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Bonnie Schouten Parcel In The Town Of Buena Vista was presented to the Board. Motion by Holets, second by Wiedenfeld that Ordinance No. 12-3 be enacted. Zoning Administrator Michael Bindl explained that 11.30 acres is being rezoned. Ms. Schouten has two properties along Highway 14. One parcel was purchased in 1990 and the second parcel was purchased in 2004. ### **ORDINANCE NO. 12 - 3**

Amendment # 330 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Bonnie Schouten Parcel In The Town Of Buena Vista.

The Richland County Board of Supervisors does hereby ordain as follows:

1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:

- (a) Adequate public facilities to serve the development are present or will be provided.
- (b) Provision of these facilities will not be an unreasonable burden to local government.
- (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
- (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
- (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
- (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
- (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.

2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described real estate in the Town of Buena Vista is hereby rezoned from the General Agricultural and Forestry District to the Single Family Residential (R-2) District:

Commencing at the Northeast corner of the Southeast Quarter of the Northwest Quarter (SE<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>), thence South along said forty line to the North right-of-way line of US Highway 14, thence Northwesterly along said US Highway 14 right-of-way line to the center of Bear Creek, thence Northerly along the centerline of Bear Creek to the North line of the Southeast quarter of the Northwest quarter, thence Easterly along the North line of said forty to the point of beginning, said lands being in the Southeast Quarter of the Northwest Quarter (SE<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>) of Section Three (3), Town Eight (8) North, Range Two (2) East, Richland County, Wisconsin.

3. This Ordinance shall be effective on March 20, 2012.

### **RESOLUTION NO. 11-127** (Substitute Amendment)

A Resolution Relating To Concealed-Carry Legislation Which Was Recently Enacted By The Wisconsin Legislature.

WHEREAS the Wisconsin Legislature recently enacted, and the Governor signed, so-called concealedcarry legislation which enables citizens, after complying with certain requirements, to carry concealed weapons, and

WHEREAS, under that legislation, counties have discretion as to whether to allow concealed weapons to be carried in County buildings and also whether to allow County employees to carry concealed weapons during the course of their employment, and

WHEREAS the Rules and Resolutions Committee has carefully considered this matter and, with the advice of Corporation Counsel Ben Southwick, is now presenting this Resolution to the County Board for its consideration.

NOW, THEREFORE, BE IT RESOLVED by the Richland County Board of Supervisors that, except as otherwise provided in this Resolution, the appropriate supervising Committee or Board shall ensure that signs are placed in accordance with this Resolution providing notice that firearms are not permitted in:

- (a) Any building owned or operated by the County, including any facility operated jointly by the County and the City of Richland Center;
- (b) The common areas of any non-residential building owned or operated by the County, and

BE IT FURTHER RESOLVED that all County officers and employees are prohibited from carrying firearms during the course of their employment or in County-owned vehicles, and

BE IT FURTHER RESOLVED that this Resolution does not apply to:

- (a) Any law enforcement officer;
- (b) A weapon in the Courthouse or Courtroom if a Judge who is a licensee is carrying a weapon or if another licensee or out-of-State licensee, whom a Judge has permitted in writing to carry a weapon, is carrying the weapon;
- (c) A weapon in the Courthouse or Courtroom if the District Attorney or an Assistant District Attorney who is a licensee is carrying the weapon., and
- (d) Any building on or associated with the University of Wisconsin-Richland campus, and

BE IT FURTHER RESOLVED that the first paragraph (b) of this Resolution does not apply to a person who occupies residential premises in a non-residential building owned or operated by the County, and

BE IT FURTHER RESOLVED that the following definitions apply:

- (a) "Electric weapon" means any device which is designed, redesigned, used or intended to be used offensively or defensively, to immobilize or incapacitate persons by the use of electric current;
- (b) "Firearm" means a weapon that acts by force of gunpowder;
- (c) "Handgun" means any weapon which is designed, redesigned, or made or remade, and intended to be fired while held in one hand and to use the energy of an explosive to expel a projectile through a smooth or rifled bore. - (g) "Out-of-State licensee" is an individual who is 21 years of age or over, who is not a Wisconsin resident and who has been issued an out-of-State license as that term is defined in Wisconsin Statutes, section 175.60 (1) (f);
- (h) "Switchblade knife" means any knife having a blade which opens by pressing a button, spring or other device in the handle or by gravity or by a thrust or movement;
- (i) "Weapon" which means a handgun, an electric weapon, a knife other than a switchblade knife or a billy club, and

BE IT FURTHER RESOLVED that the Director of the Emergency Management Department, Darin Gudgeon, is hereby authorized to sign on behalf of the County such documents as may be necessary to carry out this Resolution, and
