

**MINUTES  
RICHLAND COUNTY HEALTH AND HUMAN SERVICES  
OCTOBER 12, 2006**

The monthly meeting of the Richland County Health and Human Services Board was called to order at 9:30 a.m. October 12, 2006 by Ann Greenheck in the Main Conference Room of the Community Services Building, 221 West Seminary Street, Richland Center, Wisconsin.

Members Present: Ann Greenheck, Daniel Carroll, Dr. Richard Edwards, Gaylord Deets, Glenn Ferguson, Jane Greiling, Jeanetta Kirkpatrick, and Ray Schmitz.

Members Absent: William Seep.

Others Present: Barb Scott, Christy Duhr, Linda Symons, Marianne Stanek, Patrick Metz, Randy Jacquet, Robin Reser, Stacy Hach, Tracy Thorsen, and Angie Rizner.

Approval of Agenda and Posting: Motion by Jane Greiling, seconded by Glenn Ferguson to approve the agenda and proper posting. Motion carried.

Approve September 14, 2006 Board Minutes: Motion by Dr. Richard Edwards, seconded by Daniel Carroll to approve the minutes of the last Health and Human Services Board meeting. Motion carried.

Approve September 25, 2006 Special Budget Minutes: Motion by Glenn Ferguson, seconded by Gaylord Deets to approve the minutes of the Special Budget meeting. Motion carried.

Citizen Comments:

Approval of Health and Human Services Vouchers: The Richland County Health and Human Services 2006 Voucher Report was distributed. Ann Greenheck noted that there were a number of large mileage reimbursements this month, but the majority of these are for volunteer drivers. Clarification was made to Jeanetta Kirkpatrick regarding State Contracts. Motion made by Gaylord Deets, seconded by Glenn Ferguson to approve the 2006 Richland County Health and Human Services vouchers listed below. Motion carried.

2006 Budget Update: Patrick Metz distributed the 2006 Budget Report for Period Ending September 30, 2006, and noted an overage of \$8,310. Patrick Metz noted that September was a three-payroll month and the incoming 10% administrative fee for state contracts has greatly helped our budget. Discussion was held regarding the Resource Center being significantly under budget at this time. Discussion was held regarding the funding sources for General Relief. Christy Duhr reported that we receive funds from the State and \$15,000 in County Tax Levy every year. It was noted that a State Contract is still outstanding of nearly \$29,500 in additional income. Patrick Metz noted that additional income and expenses are anticipated throughout the remainder of the year, but these cannot be posted in advance.

Ann Greenheck reported that Medicare payments are behind at this time for Pine Valley Healthcare, and questioned whether or not our agency is seeing the same delay. Patrick Metz stated that he is not aware of any delays at this time.

Patrick Metz reviewed the YTD Institutional Costs of \$12,943 for mental health institutes and \$60,905 for child care institutes. It was noted that there is still one child placed at Lad Lake and it is anticipated that this child will remain there through the end of the year. Tracy Thorsen noted that we have a significant credit at Mendota Mental Health Institute.

Stacy Hach reported from the CMO Enrollment Report, and noted a slow but steady increase to 350 members. The CMO Income Statement reflected a loss of \$10,003, which included a three-payroll month. It was noted that IBNR dropped and leveled off slightly. Stacy Hach noted that we received payment from the State, and would be passing those funds on as a nursing home reimbursement payment.

2007 Budget Update: Patrick Metz reported that the CMO was conservative with projecting a 1% rate decrease for the 2007 budget as presented at the last meeting. However, the State rate was increased by 5.4%, so there may be a potential of the CMO reimbursing the County Risk Reserve for part of the loan again in 2007. Discussion was held regarding the \$10 million in capitated payments. Discussion was held regarding the amounts that must be placed aside in Risk Reserve for Stop/Loss Insurance. Stacy Hach noted that this insurance premium would increase based on the number of counties involved. At this time, it is unknown which counties would participate in the insurance, but it is not likely that many would participate. Stacy Hach noted that Kenosha County is submitting an application to become a CMO.

Stacy Hach presented a handout that compared the old projected 2007 CMO budget and the new projected 2007 CMO budget, which now reflects a surplus of \$218,707. Stacy Hach noted that the CMO counties are now able to increase some provider rates by up to 3.5%. It was reported that the State is offering an "Enhanced Admin" rate of 9.25% and the risk margin added a 4% increase in our capitation rate due to the small size of our county. These were two factors that attributed to the 2007 CMO budget adjustment.

Randy Jacquet noted that Teri Buros has contacted the Chair of the County Finance Committee regarding how to revise the CMO budget documents at the County Board level. It was noted that the CMO budget is county tax levy neutral, however it would be preferred to have the documents updated at the county level.

Approval of Computer Replacement Parts Purchase (Mailout #5): A revised handout was distributed. Randy Jacquet noted that we were not able to budget for new computers in 2007, so this proposal is a cost effective measure to rebuild equipment that we already own. Barb Scott noted that our local vendors were not able to bid the same specifications as the Internet vendors, so they bid a higher product. Motion by Gaylord Deets, seconded by Dr. Richard Edwards to approve the Computer Replacement Parts Purchase from TigerDirect, totaling \$3,860.78, and forward onto the Finance Committee for approval. Motion carried.

Approval of New Hires, Resignations, and Probationary Evaluations:

New Hires: Randy Jacquet announced the recommended hiring of Rachel McGlynn, Children with Disabilities Care Manager; Teresa Judd, Economic Support Specialist; and Cheryl Blair, CMO RN Care Manager. It was noted that Teresa Judd's pre-employment agreement includes time off without pay of 2 days in 2006 and 1 day in 2007. It was noted that Cheryl Blair's pre-employment agreement includes time off without pay of up to 5 days in 2007. Motion made by Dr. Richard Edwards, seconded by Glenn Ferguson to approve the hiring of Rachel McGlynn, Children with Disabilities Care Manager; Teresa Judd, Economic Support Specialist; and Cheryl Blair, CMO RN Care Manager. Motion carried.

Resignations/Retirements: None.

Probationary Evaluations: Randy Jacquet informed the Board that Phil Ninedorf, Temporary/Casual Driver, has met the required 910 hours to successfully complete his probationary period. Randy Jacquet also informed the Board that Erin Wilson, CCS Clinician; Patricia Kemerling, CMO Social Work/Care Manager; Renee Knoble, CMO Social Work/Care Manager; and Connie Monroe, Resource Center Specialist, have all successfully completed their probationary periods. Motion by Glenn Ferguson, seconded by Jane Greiling to approve the probationary periods of Phil Ninedorf, Temporary/Casual Driver; Erin Wilson, CCS Clinician; Patricia Kemerling, CMO Social Work/Care Manager; Renee Knoble, CMO Social/Work Care Manager; and Connie Monroe, Resource Center Specialist. Motion carried.

Approval of Updated Local Union 2085 Job Descriptions (Mailout #1): Randy Jacquet informed the Board that these job descriptions are being updated to offer more uniformity, clarify job duties, and update out of date information. Angie Rizner reviewed the job descriptions in more detail, and noted that the Local Union 2085 planned to review the job descriptions at their meeting Monday, October 9, 2006. It is unknown at this time whether or not there would be any further revisions initiated by the union, but this would be finalized prior to presenting the job descriptions to the Personnel

Committee. Motion by Jeanetta Kirkpatrick, seconded by Ray Schmitz to approve the 11 updated Local Union 2085 job descriptions (pending Local Union 2085 approval), and forward them onto the Personnel Committee and County Board. Motion carried.

Approval of Community Services Building Lease Agreements (Mailout #2): Angie Rizner reported the Attorney Ben Southwick has created new leases with the United Migrant Opportunity Services (UMOS) and the Southwest Community Action Program (SWCAP) for their rented office space at the Community Services Building from July 1, 2006 – June 30, 2007. It was noted that UMOS's rent including janitorial services for 348 square feet would be \$388.89 per month. It was noted that SWCAP's rent including janitorial services for 350 square feet would be \$391.12 per month. It was also noted that the rent charged goes directly to the County's General Fund. Motion by Daniel Carroll, seconded by Gaylord Deets to approve the Community Services Building Lease Agreements with UMOS and SWCAP and authorize Ann Greenheck to sign the agreements. Motion carried.

Approval of Children's Services Unit File Folders Purchase (Mailout #3): Motion by Jeanetta Kirkpatrick, seconded by Jane Greiling to approve the Children's Services Unit File Folders Purchase from Filing Systems Specialists, totaling \$1,057.50. Motion carried.

Approval of Postage Meter Purchase (Mailout #4): Discussion was held regarding the \$35.00 per month meter rental. Motion by Jeanetta Kirkpatrick, seconded by Dr. Richard Edwards to approve the Postage Meter Purchase from Advanced Business Systems, Inc., totaling \$2,085 with a monthly meter rental of \$35.00. Motion carried.

Discussion of Rural Transportation Request for Proposal (Mailout #6): Linda Symons noted that this request for proposal is being presented to this Board, as the Transportation Coordinating Committee is not scheduled to meet until after this proposal expires. It was noted that if we were awarded this grant, we would have to offer match funds. Linda Symons stated that there is an internal workgroup meeting to discuss this issue and the lack of transportation services offered to the citizens of Richland County. Motion by Daniel Carroll, seconded by Jane Greiling to approve the application of the Rural Transportation Request for Proposal. Motion carried.

Approval of Contracts, Amendments, and Providers:

2006 Amended HHS Contracts (Mailout #7): A revised mailout was distributed. Discussion was held regarding whether or not ANEW Healthcare Services is a fiscal agent rather than a provider of respite services for Health and Human Services. Robin Reser noted that the CMO uses ANEW only as a fiscal agent. It was determined that approval of this contract would be postponed until clarified with Byron Smith. Tracy Thorsen reported on the adult family home rate adjustments due to the addition of Comprehensive Community Services. It was noted that these rate adjustments are retroactive.

2007 New CMO Provider Network (Mailout #8): Robin Reser reviewed the new 2007 CMO Provider Network. Dr. Richard Edwards questioned what Kaul Communications provides. Robin Reser stated that she would check into this and report back at the next meeting.

Robin Reser noted that the Wiedenfeld AFH contract would not be entered into for 2007, and would be eliminated from this network. It was noted that county certified adult family homes are 1 or 2 bed homes, state certified adult family homes are 4 bed homes, and more than 4 beds homes are community based residential facilities. Discussion was held regarding the difficulty that law enforcement is having when dealing with high needs clients placed in state certified adult family homes. Robin Reser stated that she would invite law enforcement to attend an upcoming adult family home provider training.

Robin Reser noted that at times she has had difficulty negotiating some provider rates, since similar providers supplying similar services should be paid similar rates.
