6. Elder Benefit Specialist Program Quarterly Report

- Joanne Welsh, Elder Benefit Specialist gave a presentation about the Elder Benefit Specialist Program.
 - What is a Benefit Specialist?
 - Advocate for public and private benefit problems
 - Advocate for people over 60
 - o Who Administers the Elder Benefit Specialist Program
 - Richland Co. Health & Human Services
 - Aging & Disability Resource Center of Eagle Country
 - Who should seek help from the Elder Benefit Specialist
 - People over 60 who want to know about private and public benefits
 - Older people who have been denied benefits/services which they think they are qualified
 - Older people who need legal representation
 - Older people having difficulty making monthly expenses
 - Family/Caregivers working with older adults who may qualify for public benefits
 - What can a Benefit Specialist help with?
 - Medicare Benefits, Prescription Assistance, Medigap/Supplemental Insurance, Medicare Advantage, SeniorCare, SSI/Supplemental Security Income, Social Security Benefits, Disability Benefits, Medical Assistance, Food Stamps, Housing/Tenant Problems, Pension Problems, and other legal or benefit problems.
 - What are examples of a successful Benefit Specialist case?
 - Joanne gave two examples of how she has helped people in the past
 - All the parts of Medicare.
 - Part A Hospital
 - Part B Doctor (Medical)
 - Part C Medicare Advantage private health insurance that is optional to regular Medicare
 - Part D Prescription drug insurance approved by Medicare
 - Who is affected by Medicare Part D
 - Medicare beneficiaries regardless of age
 - Those with drug coverage currently through employer/retiree insurance
 - Those on Medicare & Medicaid
 - Those without any prescription coverage
 - •

- o Questions you would need to ask
 - Is my drug coverage creditable
 - Do I continue with that coverage or sign up for Part D?
 - Will I pay a penalty for Part D if I enroll at a later date?
 - Do I qualify for extra help paying for Part D?
 - In SeniorCare a better option than Part D if I am over 65?
- o Medicaid Benefits and Part D
 - Medicaid is a combination of state and federal health insurance for those with limited income and assets.
 - Effective Jan. 1, 2016 Medicare will no longer cover prescriptions.
 - Medicaid will still cover hospital and medical services.
 - Dual eligibles will be automatically enrolled in extra help paying for Medicare Part D. If they
 are dissatisfied with the plan they are enrolled in, they can change plans.
- Helpful Benefits to Help with Health Care Costs
 - LIS/Extra Help
 - QMB/SLMB
 - FoodShare/Food Stamps

7. Dementia Friendly Communities Initiative 2016

- Roxanne Klubertanz-Gerber gave an update. She stated that she will give an update at every meeting.
- Roxanne will be meeting with businesses in the next couple of months to discuss this issue. She will also be doing press releases and radio ads.
- Belinda Granger was asking if this was part of the Angel network. Roxanne said it wasn't. There is confusion because of the two different programs doing the same thing. Roxanne will get with Becky Dahl to discuss this.
