## **AUGUST SESSION**

August 15, 2017

Chairman Kirkpatrick called the meeting to order. Roll call found all members present except Jewell.

Supervisor Seep gave the Invocation. County Clerk Vlasak led the Pledge of Allegiance.

County Clerk Vlasak read the agenda for the August session. Motion by Peters, second by Kinney that the agenda be approved and that the Wednesday mail-out rule be set aside so that action can be taken on the resolution that was mailed out after Wednesday. Motion carried.

Chairman Kirkpatrick asked if any member desired that the minutes of the July session be read or if any member desired to amend the minutes of the previous session. Hearing no motion to read or amend the minutes of the July session, the Chairman declared the minutes as approved.

Chelsea Wunnicke, Family Living Agent with the University of Wisconsin Cooperative Extension, addressed the Board and provided information regarding the Richland County Homelessness Prevention Coalition. Wunnicke is one of the members of the Homelessness Prevention Coalition. Copies of the current Homelessness Prevention Coalition brochure were distributed to Board members. Wunnicke noted that more than one organization serves the homeless in Richland County. The purpose of the Coalition is to bring the groups together on a monthly basis to share ideas, problem solve and look for better ways to serve the homeless population and hopefully eliminate the problem in Richland County. It is a requirement by the Southwestern Wisconsin Community Action Program that there be a Homelessness Prevention Coalition in Richland County because the grants received by SW CAP from the State can only be released into counties where there is an official Homelessness Prevention Coalition presence. The resources help homeless people get back into housing by paying their security deposit or part of their rent until they get back on their feet. The resources also are used to prevent homelessness by paying back rent. Twice a year the Homelessness Coalition is tasked with doing a point in time count. The last count was conducted in July. Pat Greeley, co-leader of the group, was present. Wunnicke provided statistics on the results of the count.

Jay B. Mueller, provided information regarding Lydia's House which is supported by funding from local churches. The Ministerial Association, comprised of fifteen ministers, has a mission of helping people in need. Lydia's House is an emergency shelter where people can stay for fifteen days. A Child's Place is another emergency shelter where people to stay for three months. A Family place will house people for longer periods of time. Mentoring, direction and assistance is provided to people in need. Mueller provided examples of situations where assistance has been provided.

Ordinance No. 17-15 Amendment No. 432 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Donna Pauls and Annaliece Rynes Parcel In The Town Of Orion was read by County Clerk Vlasak. Motion by Sebranek, second by Peters that Ordinance No. 17-15 be enacted. Zoning and Land Information Committee Chairman Sebranek explained the rezoning request. Motion carried and ordinance declared enacted.

### **ORDINANCE NO. 17 - 15**

Amendment No. 432 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Donna Pauls and Annaliece Rynes Parcel In The Town Of Orion.

The Richland County Board of Supervisors does hereby ordain as follows:

- 1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:
  - (a) Adequate public facilities to serve the development are present or will be provided.
  - (b) Provision of these facilities will not be an unreasonable burden to local government.

- (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
- (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
- (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
- (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
- (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.
- 2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described 4.41 acre parcel belonging to Donna Pauls and Annaliece Rynes in the Town of Orion is hereby rezoned from the General Agricultural and Forestry District to the Single-Family Residential (R-2) District:

Lot 1 of Certified Survey Map # 837 which was recorded on May 22, 2009 as Document # 287347 in Volume 7, Certified Survey Maps, pages 259-261, Richland County Register of Deeds.

3. This Ordinance shall be effective on August 18, 2017.

Resolution No. 17-78 Relating To The County Obtaining A Tax Deed To Certain Tax Delinquent Real Estate In The Village of Cazenovia was read by County Clerk Vlasak. Motion by Williamson, second by B. Marshall, Jr. that Resolution No. 17-78 be adopted. Corporation Counsel Southwick explained that a proposal will be made to the Property, Building and Grounds Committee to enter into a contract with the Village of Cazenovia which wants to acquire ownership of this parcel. The contract basically would be that the County would deed this parcel to the Village in exchange for the Village paying all of the back taxes. Such an

arrangement is allowed by State Statute. A claim against the County for the cleanup of the parcel by the Village would also be released as a part of the contract. Motion carried and resolution declared adopted.

### **RESOLUTION NO. 17 - 78**

The lowest bid of Johnson Controls of Onalaska, Wisconsin in the amount of \$62,751.08 to replace the condensing unit in the Science Building with a 60 ton R22 Trane condensing unit and replace the heating coil in the air handler unit, all relating to heating and cooling the building, is hereby accepted and the contract for this work is hereby awarded to that firm, and

BE IT FURTHER RESOLVED that the County's cost of \$14,800 to have an engineering firm prepare plans and specifications for the roof replacement project, which cost was approved by Resolution # 15-71 which was adopted on May 16, 2017, shall be returned to the UW-Richland Outlay account in the 2017 County budget after the loan funds to pay for these projects has been received, and

# **RESOLUTION NO. 17 - 84**

A Resolution Approving Borrowing \$272,000 From The Board Of Commissioners Of Public Lands For The Purpose Of Financing Renovation Projects At The University Of Wisconsin-Richland.

WHEREAS, by the provisions of Sec. 24.66 of the Wisconsin Statutes, all municipalities may borrow money for such purposes in the manner prescribed, and

WHEREAS, by the provisions of Chapter 24 of the Wisconsin Statutes, the Board of Commissioners of Public Lands of Wisconsin is authorized to make loans from the State Trust Funds to municipalities for such purposes. (Municipality as defined by Sec. 24.60(2) of the Wisconsin Statutes means a town, village, city, county, public inland lake protection and rehabilitation district, town sanitary district created under Sec. 60.71 or 60.72, metropolitan sewerage district created under Sec. 200.05 or 200.23, joint sewerage system created under Sec. 281.43 (4), school district or technical college district).

NOW THEREFORE, BE IT RESOLVED that the County of Richland, Wisconsin, borrow from the Trust Funds of the State of Wisconsin the sum of Two Hundred Seventy Two Thousand and 00/100 dollars (\$272,000.00) for the purpose of financing renovation projects at UW-Richland and for no other purpose, and

BE IT FURTHER RESOLVED that the loan is to be payable within 5 years from the 15<sup>th</sup> day of March preceding the date the loan is made. The loan will be repaid in annual installments with interest at the rate of 3.00 per cent per annum from the date of making the loan to the 15<sup>th</sup> day of March next and thereafter annually as provided by law, and

BE IT FURTHER RESOLVED that there shall be raised and there is levied upon all taxable property, within the County of Richland, Wisconsin, a direct annual tax for the purpose of paying interest and principal on the loan as they become due, and

BE IT FURTHER RESOLVED that no money obtained by the County of Richland by such loan from the state be applied or paid out for any purpose except financing renovation projects at UW-Richland, without the consent of the Board of Commissioners of Public Lands, and

### ORDINANCE NO. 17 - 18

Amendment No. 434 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Brett and Amanda Keller Parcel In The Town Of Westford.

The Richland County Board of Supervisors does hereby ordain as follows:

- 1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:
  - (a) Adequate public facilities to serve the development are present or will be provided.
  - (b) Provision of these facilities will not be an unreasonable burden to local government.
  - (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
  - (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
  - (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
  - (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
  - (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.

2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described 21 acre parcel belonging to Brett and Amanda Keller in the Town of Westford is hereby rezoned from the General Agricultural and Forestry District to the Agricultural and Residential District:

Including Part of the northwest quarter of the northwest quarter and part of the northwest quarter of the northwest quarter all in section 11, Township 12 North, Range 2 East, Town of Westford, Richland County, Wisconsin, more particularly described as follows:

The Supervisors discussed the question of presenting a Resolution to the County Board directing the County Clerk to work on a Resolution calling for a referendum question as to whether the County should be authorized to exceed levy limits and increase the annual tax levy. Chairman Kirkpatrick stated that having received the advice of the Committee on Committees and subject to confirmation by the County Board she was appointing David Turk and Melissa Burke to the Southwest Wisconsin Community Action Program Board. Motion by Williams, second by Huffman to confirm the appointments. Motion carried. Ruth Williams has submitted her resignation from the Southwest CAP Board.

Chairman Kirkpatrick reported that nominations are being accepted for appointment to the Southwestern Wisconsin Regional Planning Commission to fill the position formerly held by Robert Smith. Nominations will be forwarded to Governor Scott Walker from which he will make an appointment.

Pine Valley Trustee Chairman Clary reported that the Pine Valley Construction Project is progressing. The project continues to be under budget. Blacktopping as well as some window and siding replacement and landscaping still need to be completed. The project is 99% complete.

Supervisors were provided with copies of reports from County departments on strategies they have taken to reduce costs in the 2017 budget.

Zoning and Land Information Chairman Sebranek reported that no petitions for zoning amendments have been received since the last County Board session and that there are no rezoning petitions being recommended for denial by the Zoning and Land Information Committee.

Motion by Huffman, second by Peters to adjourn to Tuesday, September 19, 2017 at 7:00 p.m. Motion carried.
