 - b. Interim 4-H Program Coordinator position and related staffing—Saxe presented the decision from the June meeting Ag and Extension Education committee to the State of Wisconsin UW System. The proposal included sharing an Agriculture Agent with a neighboring county (reducing Richland County support to 0.5 FTE for this position) and supporting a 1.0 FTE in a Youth & Families Educator role for Richland County.
