ANNUAL SESSION

October 29, 2019

Chairman Kirkpatrick called the meeting to order. Roll call found all members present except Manning.

Reverend Michelle Elfers, Pastor of St. John's Lutheran Church, Richland Center, gave the Invocation. County Clerk Vlasak led the Pledge of Allegiance.

County Clerk Vlasak read the agenda for the Annual session. Motion by Cosgrove, second by Peters that the agenda be approved and that the Wednesday mail-out rule be set aside so that the resolution which was not mailed out could be acted upon at this session.

Chairman Kirkpatrick asked if any member desires the minutes of the September session to be read or if any member desires to amend the minutes of the previous session. Hearing no motion to read or amend the minutes of the September session, the Chairman declared the minutes as approved.

The County was presented with a check in the amount of \$34,149.90 from the Wisconsin County Mutual Insurance Corporation. The check represents a flat dividend on the workers compensation policy for the 2017-2018 policy period.

Chair Kirkpatrick opened the Public Hearing on the proposed 2020 Richland County Budget.

Highlights of the proposed 2020 budget are as follows:

- Proposed 2020 expenditures are \$32,555,314.24. An increase of \$2,947,386.63 over 2019.
- Proposed 2020 revenues are \$23,701,356.27. An increase of \$2,840,124.32 over 2019.
- Proposed tax levy is \$8,853,957.97. An increase of \$107,263.31 over 2019.
- Equalized values are (TID Out) \$1,202,545,400.00. The rate per thousand of assessed value is \$7.36 compared to \$7.60 for last year.
- Health insurance premium increases of 1.5%. The deductibles were increased from \$1,500 Single/\$3,000 Family to \$3,000 Single/\$6,000 Family.
- Funding for the new County Administrator position.
- Funding for the new Economic Development position. 40% of the funding for the position will come from the City of Richland Center.
- Funding for costs associated with an additional pay period.
- Funding request for a new jailor/dispatcher position and road patrol position were removed.
- Outstanding debt totals \$24,247,143.52. Debt will be refinanced to take advantage of lower interest rates.
- Funds applied include \$137,891.02 from the General Fund, \$127,688.32 from the Debt Service Fund and \$100.017.82 from the Land Records Fund.
- Anticipated County sales tax revenues were increased from \$1,150,000.00 to \$1,250,000.00.
- General Fund balance as of December 31, 2018 is \$3,928,702.00.

Motion by Brewer, second by Sebranek to close the Public Hearing. The motion carried.
