# Recommendation and/or action language:

Motion to... propose amendment to the Richland County Board Rule #14 increasing expenditure authority threshold of department heads from "\$1,000 or less," to "\$1,999.99. or less"

**Background:** (preferred one page or less with focus on options and decision points)

Current language of the Richland County Board Rules contains ambiguous language that leads to some confusion regarding expenditure authority. Current language states, "If the purchase price of the needed property including computers is \$1,000 or less, the department head may make the purchase upon obtaining at least one quotation from a vendor. If the purchase price of the needed property including computers is between \$2,000 and \$5,000, the purchase must be made by the appropriate committee of the County Board after having obtained a minimum of 3 quotations from vendors, if reasonably possible."

This language calls into question the authority for purchases from \$1,000 to \$1,999.99. It is proposed that the Rule 14 language, section (b), be amended to allow for department head authority up to \$1,999.99.

#### [Richland County Rules of the Board; Page 6] - Proposed Change

(b) Expenditures. If the purchase price of the needed property including computers is \$1,000 \text{\text{\gamma}}1,999.99} or less, the department head may make the purchase upon obtaining at least one quotation from a vendor. If the purchase price of the needed property including computers is between \$2,000 and \$5,000, the purchase must be made by the appropriate committee of the County Board after having obtained a minimum of 3 quotations from vendors, if reasonably possible. No Committee may commit Richland County to an expenditure in excess of \$5,000.00 for the purchase of property, supplies or equipment (in either one unit or in multiple of units if the cost of either exceeds \$5,000.00) or of real estate or for the repair, renovation, remodeling or reconstruction of buildings or other public works, unless that expenditure has been approved by the County Board.

#### Recommendation and/or action language:

Recommend a motion, to present a resolution to the County Board to conduct a countywide advisory referendum on creation of nonpartisan procedure for the preparation of legislative and congressional redistricting plans and maps.

#### **Background:**

On October 31, 2017, the Richland County Board of Supervisors passed Resolution #17-99 regarding a non-partisan procedure for drafting legislative and congressional districts in Wisconsin (see Attachment A). At that time, only one county's voters had passed an advisory referendum regarding fair maps (Dane County in April 2014). Since then voters in 27 additional counties have passed an advisory referendum (see Attachment B), including the neighboring counties of Crawford (November 2020), Iowa (November 2020), Sauk (November 2018), and Vernon (April 2019).

A template for a resolution is shown in Attachment C. For the advisory referendum to appear on the April 6, 2021 ballot, the resolution would need to be adopted at the December or January County Board meeting. This is due to Wisconsin Statute 8.37, which requires that referenda questions "be filed with the official or agency responsible for preparing the ballots for the election no later than 70 days prior to the election at which the amendment, measure or question will appear on the ballot."

# **Richland County Board of Supervisors**

#### **OCTOBER SESSION**

October 31, 2017

Chairman Kirkpatrick called the meeting to order. Roll call found all members present except Huffman and Williamson.

Reverend Larry Engel, Pastor of the Five Points Lutheran Church, Blue River, gave the Invocation. County Clerk Vlasak led the Pledge of Allegiance.

County Clerk Vlasak read the agenda for the October session. Motion by Kinney, second by Bellman that the agenda be approved. Motion carried.

Chairman Kirkpatrick asked if any member desired that the minutes of the September session be read or if any member desired to amend the minutes of the previous session. Hearing no motion to read or amend the minutes of the September session, the Chairman declared the minutes as approved.

The Public Hearing on the proposed 2018 budget was opened by Chairman Kirkpatrick. Chairman Kirkpatrick began by thanking the members of the Finance and Personnel Committee, County Clerk Vlasak and Department Heads for their work in the preparation of the proposed budget. The tax levy for the proposed budget is \$8,337,004.75. Revenues have increased by \$1,964,030 compared to the 2017 budget and expenditures have increased by \$3,418,044 compared to the 2017 budget. The tax levy increase is \$1,454,014 compared to the previous year's levy. The proposed budget includes funds to cover a 7% increase in health insurance premiums; a 2% wage increase to cover the cost of implementing the wage study and an additional \$480,104 for institutional costs. It was noted that the \$809,619 budgeted in 2018 for institutional costs will not fully cover the costs which are estimated at 1.1 million for 2017. The levy request by the Health and Human Services Department was reduced by \$40,000. Pine Valley's levy request was reduced by \$117,058. The entire debt service payment for the new Pine Valley facility in the amount of \$1,371,500 has been included in the proposed levy. The Highway Department's levy request was reduced by \$136,500. The proposed budget reduces the hours of a position at the Cooperative Extension office, eliminates a position in the District Attorney's office and reduces the hours of a position in the Child Support Agency. The levy for the proposed budget will result in taxes of \$761 for property valued at \$100,000. This is an increase of \$119 from last year. Discussion followed. Motion by Kirkpatrick, second by Sebranek that the Public Hearing be closed. Motion carried.

A Resolution To Create A Non-Partisan Procedure For Drafting Legislative And Congressional Districts In Wisconsin.

WHEREAS, in accordance with the Wisconsin Constitution, every 10 years after the decennial census, the Legislature must redraw Legislative and Congressional districts in accordance with the one person-one vote rule, and these districts are used to elect members of the Legislature and Congress for the next decade, and

WHEREAS the drawing of these has been the subject of partisan influence, often called gerrymandering, and costly litigation, with Wisconsin's current district maps being the subject of a much-anticipated U.S. Supreme Court decision, all of which could be avoided by the establishment of a non-partisan procedure for the drawing of Legislature and Congressional districts, and

WHEREAS the Rules and Resolutions Committee has carefully considered this matter is is now presenting this Resolution to the County Board for its consideration.

NOW THEREFORE BE IT FURTHER RESOLVED by the Richland County Board of Supervisors that the County Board urges the Legislature to create a non-partisan procedure for the drawing of Legislative and Congressional districts, and to do this promptly and without waiting until the 2020 census, and

BE IT FURTHER RESOLVED that the County Clerk is hereby directed to send a copy of this Resolution to

Governor Scott Walker, to all State legislators whose districts include any portion of Richland County and to the Wisconsin Counties Association, and

**WHEREAS**, the [if applicable Name of County] County Board of Supervisors on [DATE] passed a resolution calling for nonpartisan legislative and congressional redistricting maps; and

WHEREAS, pursuant to Article IV, Section 3 of the Wisconsin Constitution, the Wisconsin Legislature is directed to redistrict state legislative districts "according to the number of inhabitants" at its next session following the decennial federal census. The legislature also reapportions congressional districts at the same interval pursuant to federal law; and

WHEREAS, there are numerous indicators that the citizens of Wisconsin are concerned about the practice of redistricting by whichever party holds the majority, because it may stifle political participation and competition, discourage collaboration and compromise, and lack the fairness necessary to our democratic process, by undermining the principle of one-person-one vote.

**WHEREAS**, the current procedure allows the legislature of the majority party to prepare redistricting plans and maps that may result in unfair partisan plans and maps, allowing the legislature to choose its voters rather than the voters choosing their representatives, which is commonly called gerrymandering.

**NOW, THEREFORE, BE IT RESOLVED**, that the [Name of County] County Board of Supervisors, in legal session assembled, does hereby approve that the following question be placed on the [Date of Election] ballot as an advisory referendum question:
