Motion to approve expenditures from the capitol borrowing fund #75 and recommend resolution to the Richland County Board in the amount of \$30,000, to Garage Door Express, for replacement and installation of Courthouse garage doors.

Background: (preferred one page or less with focus on options and decision points)

The Courthouse experienced a garage door failure of one of the ambulance bay garage doors. Garage Door Express was contacted to assess the problem. The assessment revealed all five bay doors are approaching the end of service life with springs and mechanics failing. Garage Door Express offered a bid of \$6,200 for the replacement of one door or \$30,000 for the replacement of all five doors. It is proposed that an apportionment of the Capital Borrowing Fund earmarked for windows be appropriated for the replacement of all five garage doors.

Two other companies were contacted for bids but failed to respond, Swenson Doors (Viroqua) and Overhead Door Company (Madison)
