"Richland County's hiring policy is intended to promote a well-qualified and diverse workforce that represents both the experience offered by organizational longevity and innovativeness gained through influx.

It shall be policy to promote career advancement opportunities from within departments, while filling positions with qualified employees, best suited for the position and whom bring diverse work-place experiences to the County.

When the County determines that a vacancy or new position shall be filled, position vacancies may be filled by the department head by promotion, transfer, demotion from within the department; or new hire from public posting. Non-elected Department heads shall be filled by the County Administrator. It is not necessary to recruit outside applicants for vacant positions when the position is filled by promotion, transfer or demotion from within the Department."

; and under Section III, A Vacancies Longer than 90 Days, as paragraph 2.

The Department Head may fill the position by promotion, transfer, demotion from within the department without public posting or external candidate consideration. When considering to fill the vacancy internally the Department Head must internally post the vacancy within the department for at least one week. When multiple, internal candidates apply, the Department Head shall evaluate through a competitive process and may offer to the best suited candidate. Until the position is filled, the Department Head has the discretion to post the vacancy publically at any time, as there is no entitlement to internal promotion for County positions, and

; and under Section III, A Vacancies Longer than 90 Days, as paragraph 3 the underlined words,

3. When a vacant position is not filled from an internal method, the Administrator or Department Head shall place an advertisement in the Richland Observer to run for at least two weeks.

BE IT FURTHER RESOLVED by the Richland County Board of Supervisors that the Handbook of Personnel Policies and Work Rules is hereby amended by adding the following underlined language and eliminating the stricken language under subheading "Hiring for Long-Term Vacancies (90 days or longer) under the heading "Hiring and Employment Considerations.:

- 1. **Hiring for Long-Term Vacancies (90 days or longer):** Whenever it appears to a Department Head that an approved job position within the department will be vacant for a period of 90 days or longer the process defined in the Richland County Administrative Manual. shall be followed:
  - a. The Department Head shall immediately notify the supervising committee and\_the County Clerk, who shall in turn notify the Finance and Personnel Committee. In case of a vacancy in

- a Department Head position, the County Clerk shall perform the hiring steps which the Department Head would otherwise do.
- b. The County Clerk or Department Head shall then place an advertisement in the Richland Observer to run for at least two weeks. The County Clerk or Department Head must also send the advertisement to the MIS Department who shall advertise the position on the County website. The advertisement shall, at a minimum briefly describe the job position, necessary qualifications, where and how to apply for the position and include the sentence that the County is an equal opportunity employer. All applicants must be directed to fill out the application form attached as Addendum B to the County's Administrative Manual unless the department has its own approved application form.
- c. The Department Head or designee and the applicable committee or board may interview those applicants who appear from their written applications to be qualified for the job;
- d. Skills testing is required for all positions. The Department Head shall determine what skill tests are necessary and appropriate for each position and when in the hiring process to administer the tests. All tests shall be designed to determine whether the applicant has the basic skills and aptitude necessary to satisfactorily perform the job duties of the position. Department Heads may seek approval from their supervisory committee and the Finance and Personnel Committee to not administer skills testing for specific positions if skills testing is not necessary to determine if the applicant has the basic skills for the position.
- e. Background checks must be performed on all final candidates prior to making an offer of employment in accordance with department policy and state and federal law. Except as otherwise required by law, the scope of the background check shall be determined by the Department Head. - f. The appropriate board or committee, after receiving the recommendation of the Department Head, shall make the final decision as to who shall be hired;

The Richland County Board of Supervisors does hereby ordain as follows:

- 1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:
  - (a) Adequate public facilities to serve the development are present or will be provided.
  - (b) Provision of these facilities will not be an unreasonable burden to local government.
  - (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
  - (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
  - (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
  - (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
  - (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.
- 2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following described 3.68 acre parcel belonging to Ron & Mary Ewing and in the Town of Richland is hereby rezoned from the General Agricultural and Forestry District (A-F) to the Single-Family Residential (R-2) District:

Being located in part of the Northwest quarter of the Southeast quarter and part of the Southwest quarter of the Southwest quarter of Section 31, Township 10 North, Range 1 East, Town of Richland, Richland County, Wisconsin more particularly described as follows:

Commencing at the South quarter corner of said Section 31;

Thence North 89°44'32" East, along the South line of the Southeast quarter, 319.92 feet;

Thence North 00°15′08" West, 1155.03 feet to a point on the centerline of State Trunk Highway 80, said point being located on the arc of a 1637.10 foot radius curve concave to the Southeast, said point being the point of beginning of the land hereinafter described;

Thence Northeasterly along said centerline and curve, 399.15 feet with a central angle of 13°58'10" and a chord bearing North 45°29'04" East, 397.95 feet;

Thence South 54°04'05" East, 351.29 feet;

Thence South 39°55'02" West, 453.21 feet;

Thence North 45°18'18" West, 390.45 feet to the point of beginning.

3. This Ordinance shall be effective on April 20th, 2021.

- 2. \$65,482.95 for 2022, that being a 2.5% increase over the 2021 salary of \$63,885.80;
- 3. \$66,682.95 for 2023, that being a \$1,200 increase over the 2022 salary;
- 4. \$67,882.95 for 2024, that being a \$1,200 increase over the 2023 salary.

WHEREAS Wisconsin Statute 59.22 does not allow increases or decreases in salary for elective offices during a term but allows changes in later terms, and

WHEREAS a review of County Clerk salaries in 13 similar counties (with a population of 15,000 to 24,000 and/or neighbors) found that the average County Clerk salary for 2021 is \$64,246, with a range of \$54,621 - \$73,502, and

WHEREAS the decrease is appropriate because the County Clerk no longer carries out duties of the Administrative Coordinator, and

WHEREAS the additional ~\$15,000 in annual County Clerk salary for the remainder of the 2021-24 term may be allocated toward non-statutory duties and to fulfill certain strategic plan and administrative priorities adopted through Resolution 20-107,

NOW THEREFORE BE IT RESOLVED when elected official salaries are set for the 2025-28 term, the salary of the County Clerk shall be reduced to equal the salary of the Register of Deeds and Treasurer, and

## Tri-County Airport Improvement Project



Presentation to: The Richland County Board – 20 Apr 2021

## What is the project and what service does it support?

The project includes raising the runway, raising the taxiway, improvements to lighting, improvements to airport drainage, improvements to drainage ditch to Bear Creek, and moving existing irrigation equipment to improve the drainage ditch. This project supports airport operations by reducing closures due to reoccurring flooding, and this project is seen as an economic development/sustainment by the Richland County, Commission members.



## Why is it needed, and when does it need to be in place?



These projects will raise the surfaces and increase drainage to help reduce flooding at the airport. There is grant funding availability from the Federal Aviation Administration in 2022. Grant funding from Wisconsin in 2023-2024 is currently designated to Mitchell and Dane County. The next opportunity may not come again until 2025. The airport continually experiences hanger flooding, a closed runway, and increased waterfowl activity resulting from inadequate drainage.

# What are the risks and consequence of going without, deferring until a later year, or reducing?

Going without the project will likely lead to prolonged periods of airport flooding, flooding of leased hangers, reduced access for local pilots and area businesses, and impacts on rented restaurant. Deferring to later years would either suspend the project to 2025 or later, or put additional expenses on our partner, Sauk County. Reducing the project would impact current efforts of joining all the improvements under one grant project, which increases likelihood of being awarded.



## Additional comments // previous history or action on this project?

This is a 9.5-million-dollar project in which the FAA would cover 90%, Wi DOT would cover 5% and we are left with a 5% local share with Sauk Co, and possible local area partner support. Discussions and negotiations with Sauk County on operation and capital appropriations

are underway.

#### Dickeyville wins \$2.87 million dollar EDA Grant

Dickeyville's U.S. Economic Development Administration (EDA) grant for \$2,867,824.80 is coupled with \$716,956.20 in local match for a total investment in the project of \$3,584,781. The EDA is paying 80% of the project through the CARES Act, which is targeted

at Coronavirus response and economic stimulus.

Construction is likely to begin in the late U.S. ECONOMIC DEVE summer of 2021 for the new 22.75 acre industry park and will take approximately seven months to complete.

"This award is the result of Dickeyville Village President Matt Gantenbein's leadership coupled with the vision and initiative of the Village Board as well as the partnership formed between the Village, SWWRPC, and Delta 3 Engineering," said Troy Maggied, Executive Director of the Southwestern Wisconsin Regional Planning Commission.

SWWRPC wrote the Dickeyville grant and since 1979,

SWWRPC has written 19 grants and been awarded over \$15 million. When matched with \$9.8 million in local funds, these projects total \$24.8 million in industry park

infrastructure funding across 13 communities. EDA grant funding is a powerful tool for community development efforts, and SWWRPC has been very successful in helping communities identify projects and acquire funding from both the EDA and other grant resources. #### Platteville Business Incubator

The Platteville Business Incubator is celebrating its 20th anniversary this year with a \$340,000 reinvestment into the 26,000 sq. ft. facility including new rentable desks and co-working space. Delta 3 Engineering is managing the renovation that will be finished in July 2021.

Temporary co-working space is already available at the Incubator at \$30/month which includes 8am-6pm access to the workspace, fiber optic internet and complementary coffee/tea. Plans offering 24-hour access and socially distanced reserved desks with storage are also available and range from \$70/month to \$120/month. In addition to the co-working space, offices and manufacturing spaces are available from 130 sq. ft. to 1800 sq. ft. with prices from \$144 to \$1,492. Tenants are also eligible to apply

for up to \$75,000 in startup or expansion capital at low interest rates and flexible terms.

The Platteville Business Incubator has onsite daycare, business mentors, educational sessions, commercial kitchen facilities, a laser cutter, group insurance, below and at-grade loading docks, forklifts and office equipment available to tenants. The Incubator has hosted 70 businesses over the last 20 years, 42 businesses remain active and those businesses employ 382 people. The Incubator currently houses 18 businesses, including technology companies, professional services, manufacturing, internet resellers and food trucks.
