STEP 8.1 Appointment Rules & Procedure

<u>Rules</u>
Each County Board member holds seats on 3 standing committees
The County Board Chair and Vice Chair are automatically members of the Finance & Personnel and Rules & Strategic Planning Committees
The Chair of each Standing Committee is a member of each Executive Committee (Finance & Personnel; Rules & Strategic Planning)
No person may be chair of more than 1 standing committee
Only a County Board member may be elected as a chair of a standing committee. Citizen members of any standing committee may be present to vote in the election of a standing committee chair.
All initial appointments are made and confirmed at the organizational meeting after the Chair and Vice Chair are elected
<u>Procedure</u>
The Board first elects by secret, formal ballot the members of the Pine Valley & Child Support Standing Committee.
The Pine Valley & Child Support Standing Committee meets to elect a Chair.
The Board Chair then recommends appointment of the County Board members of the remaining 6 non-Executive standing committees, one committee at a time: Education, Fair/Recycling/Parks, HHS & Veterans, Land/Zoning, Public Safety, and Public Works Standing Committees, with County Board confirmation
As each committee is appointed and confirmed, that committee meets to elect a Chair. The Clerk conducts each meeting until a Chair is elected. The Public Safety Standing Committee should recommend - not elect - a Chair appointment to the County Board Chair. The County Board Chair has the statutory authority to declare the Chair of the Public Safety Committee (under its powers to operate as the Emergency Management Committee).
Each committee Chair automatically become a member of the Finance & Personnel and Rules & Strategic Planning Standing Committees
If a supervisor is elected to be Chair of a standing committee and has previously received a non-Executive Standing Committee appointment, that non-Executive appointment is no longer valid and should be recommended for rescindment by the County Board Chair with County Board approval.
After the 7th non-Executive standing committee has elected their Chair, the County Board Chair then recommends appointment of County Board members to the seats vacated by Standing Committee Chairs, subject to County Board confirmation
Any remaining vacant seats are eligible for appointment at a future County Board meeting
