Lakeside: \$437804.64 – 3 Tandems-expected delivery: April (1) May (1) June (1) / \$167947.88 – 1 Tri-axle. Expected delivery December 2023.

I State: \$480690.00 – 3 tandems. Expected delivery: May 2023 / \$168900.88 – 1 tri-axle. Delivery: May 2023. Moved by Cosgrove, second by Fleming to open for discussion. Moved by Couey, second by Fleming to award the bid to I State. All voting aye, motion carried.

# b. Possible posted speed reduction CTH RC.

CTH RC is an unposted speed zone.

The process: present to Public Works. Public Safety. Finally, to County Board for approval.

Public works recommends to move forward to reduce the speed zone to 45 mph.
